A note from Congreso:

Congreso's financial results, particularly Part I, Line 19 (Revenue less expense), may vary significantly from year to year. This variability is largely driven by the timing and structure of multi-year foundation grants and the release of donor-imposed restrictions.

In some years, Congreso may receive a large multi-year grant award that is recognized in full when awarded, increasing reported revenue. In other years, substantial amounts may be recognized as net assets released from restriction, reflecting the use of previously awarded funds. Both circumstances can materially impact the reported surplus or deficit in a given year and may not reflect changes in Congreso's underlying operating performance.
